
Exercise 1: The interactive documentary

- Can you explain the link between corruption and drug prohibition in Mexico?
- Listen to the testimonies in chapter 3. Who is most to blame for the problems they have faced?
- Why are the participants in Anyone's Child: Mexico telling their stories? What do they hope to achieve?
- Reflect on your experience of the interactive documentary. Has your position changed on the drug war?


